

Resolution authorizing a contract with All State Distributors Northeast, Bob Barker Co., Columbus Candy, Centric Group, LLC dba Keefe Supply Co., Mark's Distributing, Union Supply, Inc. /Food Express USA and Village Distributors for Commissary Items for the period May 6,2008 through May 5,2009
(SHERIFF) (Est. Amount \$ 901,527.00)

WHEREAS, competitive sealed bids were received and opened by the Purchasing Department on March 26, 2008; and

WHEREAS, All State Distributors Northeast, Bob Barker Co., Columbus Candy, Centric Group, LLC dba Keefe Supply Co., Mark's Distributing, Union Supply, Inc./Food Express USA and Village Distributors were the lowest and best bidders for Commissary Items; and

WHEREAS, the bid documents including the campaign contribution affidavit, specifications, and prices submitted by **All State Distributors Northeast, Bob Barker Co., Columbus Candy, Centric Group, LLC dba Keefe Supply Co., Mark's Distributing, Union Supply, Inc./Food Express USA and Village Distributors** ITB 2008-52-16 shall be the governing term contract which is fully incorporated herein, and is binding on both parties; and

WHEREAS, the term of the contract will be for a period of one year beginning May 6, 2008 through May 5, 2009 with the option to be extended for two additional 1 - year periods with mutual consent as specified in the bid documents.; and

WHEREAS, the Franklin County Sheriff's Office recommends the bids submitted by **All State Distributors Northeast, Bob Barker Co., Columbus Candy, Centric Group, LLC dba Keefe Supply Co., Mark's Distributing, Union Supply, Inc./Food Express USA and Village Distributors** as the lowest and best bids for the Commissary Items.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:
