WHEREAS, competitive sealed bids were received and opened by the Purchasing Department on November 22, 2008; and

WHEREAS, **Ecolab, Inc and Quality Chemical, Inc.** were determined to be the lowest and best bidders for ten (10) Dishwashing/Warewashing, Detergents and Dispensing Systems and were awarded contracts on March 28, 2006 (Resolution 244-06); and

WHEREAS, **Quality Chemical, Inc.** has been purchased by **Clean All Systems, LLC D/B/A State Cleaning Solutions** and **Clean All Systems, LLC D/B/A State Cleaning Solutions** has agreed to the terms and conditions agreed to by **Quality Chemical, Inc.** and the contract assignment has been approved by the Board of Commissioners through a Novation Agreement; and

WHEREAS, **Ecolab Inc. and Clean All Systems, LLC D/B/A State Cleaning Solutions** have agreed to extend the contract for the first of two 1-year extension periods, beginning May 20, 2008 and continuing through May 19, 2009; and

WHEREAS, the bid documents, specifications, and prices submitted for the contract extension by **Ecolab Inc. and Clean All Systems, LLC D/B/A State Cleaning Solutions** for ITB 2005-02-93 shall be the governing term contract which is fully incorporated herein, and is binding on both parties; and

WHEREAS, the Franklin County Purchasing Department recommends the contract extensions submitted by **Ecolab Inc. and Clean All Systems, LLC D/B/A State Cleaning Solutions** be approved

THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:
