

Resolution amending five agreements for job readiness activities with Alvis Inc., DBA Alvis House, Franklinton Career & Technology Center, Godman Guild and Goodwill Columbus (Job and Family Services) (\$2,322,993.50)

WHEREAS, the Franklin County Department of Job and Family Services is authorized to contract with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

WHEREAS, resolution number 549-07 included contracts with Alvis, Inc., dba Alvis House, Franklinton Career & Technology Center, and Goodwill Columbus, to provide job readiness services to eligible individuals for the time period of July 1, 2007 through June 30, 2008 in the amount of \$1,238,889.75; and

WHEREAS, resolution number 583-07 included contracts with Godman Guild Association and Columbus Public Schools to provide job readiness services to eligible individuals for the time period of July 4, 2007 through June 30, 2008 in the amount of \$795,851.70; and

WHEREAS, resolution number 1096-07 amended the contracts with Alvis, Inc., dba Alvis House, Franklinton Career & Technology Center, Godman Guild Association, and Goodwill Columbus to decrease the amounts by \$181,213.20 for total amended contract amounts of \$2,641,756.75; and

WHEREAS, resolution number 54-08 amended a contract with Columbus Public Schools to decrease the amount of \$160,691.05 for an amended contract total of \$278,783.20; and

WHEREAS, the parties desire to retain the terms of the contracts with Alvis, Inc., dba Alvis House, Columbus Public Schools, Franklinton Career & Technology Center, Godman Guild Association, and Goodwill Columbus, through December 31, 2008 and increase the amounts by \$775,871.55 for total amended contract amounts of \$2,322,993.50;
