

Resolution approving seven agreements for career development services with Columbus Public Schools, Columbus State Community College (2), Eastland-Fairfield Career and Technical Schools, Godman Guild Association, Goodwill Columbus, and Roadmaster Drivers School of Ohio, Inc. (Department of Job and Family Services) (\$671,829.14)

WHEREAS, the Franklin County Department of Job and Family Services is authorized to contract with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to contract with Columbus Public Schools, Columbus State Community College, Eastland-Fairfield Career and Technical Schools, Godman Guild Association, Goodwill Columbus, and Roadmaster Drivers School of Ohio, Inc., to provide career development services for eligible individuals; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to purchase career development services from Columbus Public Schools, Columbus State Community College, Eastland-Fairfield Career and Technical Schools, Godman Guild Association, Goodwill Columbus, and Roadmaster Drivers School of Ohio, Inc., for the time period of July 2, 2008 through December 31, 2008 for a total dollar value of \$671,829.14;
