

Resolution authorizing a settlement to Donald Joyner for a disputed vehicle damage claim due to an auto accident involving a Franklin County Auditor's Deputy Inspector (Auditor's Office) (\$250.00)

WHEREAS, on July 8, 2008, Franklin County Auditor's Office Deputy Inspector, Margaret Wilkins, was involved in an auto accident; and

WHEREAS, Donald Joyner's vehicle was parked in the Fleet Management parking lot when it was struck; and

WHEREAS, Donald Joyner's vehicle was struck in the door on the driver's side by the Franklin County Weights & Measures vehicle driven by Deputy Inspector Margaret Wilkins; and

WHEREAS, Donald Joyner's vehicle was the only vehicle that sustained damage in the accident and no injuries were reported; and

WHEREAS, Franklin County will pay the insurance deductible of Two Hundred Fifty 00/100 Dollars (\$250.00) as allowed by Ohio Revised Code to Donald Joyner for the damages to his vehicle in the accident that occurred on July 8, 2008; and Donald Joyner has accepted contingent on approval by the Commissioners; and

WHEREAS, the above described settlement fairly compensates Donald Joyner for the damages to his vehicle; and

WHEREAS, by agreeing to this settlement, neither Margaret Wilkins, the Franklin County Commissioners, nor the Franklin County Auditor's Office admits to any negligence or liability arising out of the auto accident; and

WHEREAS, the above described settlement, recommended by Franklin County Fleet Management, and the Prosecuting Attorney's Office, deems it to be in the best interest of the Franklin County Board of Commissioners and the Franklin County Auditor's Office to settle the vehicle claim for Two Hundred Fifty 00/100 Dollars (\$250.00); and

BE IT RESOLVED BY THE FRANKLIN COUNTY COMMISSIONERS:

1. That the above-referenced settlement in the amount of Two Hundred Fifty 00/100 Dollars (\$250.00) is in the best interest of the Franklin County Commissioners, Franklin County Auditor's Office and the Department of Fleet Management and the same is hereby approved.
2. That upon execution of a full release in favor of the Franklin County Commissioners, Department of Fleet Management and the Franklin County Auditor's Office that is satisfactory to the Prosecutor's Office; a warrant be issued payable to Donald Joyner, and forwarded to 4392 Santa Michele Court, Columbus, Ohio 43207 as full and final settlement of this matter.
3. The attached Purchase Order in the amount of Two Hundred Fifty 00/100 Dollars (\$250.00) is hereby approved.
