

Resolution approving twelve agreements for after school programs (Department of Job and Family Services) (\$1,853,487.32)

WHEREAS, the Franklin County Department of Job and Family Services is authorized to contract with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to contract with Asian Community Services, City of Columbus Mayor's Office of Education, Columbus State Community College (Orientation to Trades and Apprenticeship Programs for Youth), Enterprise Works (Career Center for Youth), Ethiopian Tewahedo Social Services, Educational Services Center of Franklin County, Godman Guild Association, Latino Community Association of Ohio, St. Stephen's Community House, Salvation Army, Somali Community Association of Ohio and YMCA to after school programs; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to purchase after school programs from Asian Community Services, City of Columbus Mayor's Office of Education, Columbus State Community College (Orientation to Trades and Apprenticeship Programs for Youth), Enterprise Works (Career Center for Youth), Ethiopian Tewahedo Social Services, Educational Services Center of Franklin County, Godman Guild Association, Latino Community Association of Ohio, St. Stephen's Community House, Salvation Army, Somali Community Association of Ohio and YMCA for the time period of October 1, 2008 through May 31, 2009 for a total dollar value of \$1,853,487.32;
