

**Resolution amending (3) Family and Children First Council contracts for the purchase of Ohio Children's Trust Fund services with Columbus Area, Inc., Columbus Health Department, and Dungarvin Ohio, LLC, for the time period of July 1, 2007 through June 30, 2009, (Job and Family Services) (total contract amount of \$423,054.68; an increase of \$157,757.98)**

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to contract with public and private organizations for the administration of Ohio Children's Trust Fund services to eligible recipients with the use of Ohio Children's Trust Fund, Franklin County Family and Children First Council, or TANF funds pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, resolution number 417-07 included contracts with Columbus Area, Inc., and Columbus Health Department, to provide child abuse and neglect prevention services to eligible individuals through the Ohio Children's Trust Fund for the time period of July 1, 2007 through June 30, 2008 in the amount of \$262,814.38; and

**WHEREAS**, resolution number 582-07 included a contract with Dungarvin Ohio, LLC, to provide child abuse and neglect prevention services to eligible individuals through the Ohio Children's Trust Fund for the time period of July 1, 2007 through June 30, 2008 in the amount of \$45,526.07; and

**WHEREAS**, resolution number 539-08 amended the terms and amounts of the contracts with Columbus Area, Inc., Columbus Health Department, and Dungarvin Ohio, LLC, extending the terms of the contracts through September 30, 2008 and increasing the total dollar value of the agreements to \$386,355.18; and

**WHEREAS**, the parties desire to extend the terms of the contracts with Columbus Area, Inc., Columbus Health Department, Community Refugee and Immigration Services, and Dungarvin Ohio, LLC, through June 30, 2009 and to increase the amount of the contracts by \$157,757.98, increasing the total dollar value of the agreements to \$423,054.68;
