WHEREAS, the bid documents and specifications submitted by **Joseph Mercurio Produce Corporation, Lannings Food Service, Roth Produce Company, Gordon Food Service, Sysco Central Ohio, and White Feather Farms of Ohio, Inc.** for RFQ 2008-02-80 shall be the governing term contract which is fully incorporated herein, and is binding on both parties; and

WHEREAS, the contract will be for a period of January 13, 2009 through January 12, 2010; and

WHEREAS, the Franklin County Purchasing Department recommends the qualification bids submitted by **Joseph Mercurio Produce Corporation, Lannings Food Service, Roth Produce Company, Gordon Food Service, Sysco Central Ohio, and White Feather Farms of Ohio, Inc.** as qualified suppliers for Fresh Produce, Fruit and Meat; and
