

**Resolution authorizing contracts for services, subgrant awards and purchase orders for the Alvis House, Corporation for Supportive Housing, Ohio Health Research Institute, CHOICES, Hilltop Christian Community Development Corp and the Cities of Columbus, Grove City, Dublin and Upper Arlington for the American Recovery and Reinvestment Act Justice Assistance Grant (ARRA JAG) (OHS&JP) (\$377,781.42)**

**WHEREAS**, the Board has authorized the receipt of the American Recovery and Reinvestment Act Justice Assistance Grant (ARRA JAG) for the purpose of creating and retaining jobs, improving or enhancing local law enforcement and prosecution efforts and supporting crime prevention and intervention services; and

**WHEREAS**, the Bureau of Justice Assistance has administratively approved the projects listed below and identified Franklin County as the applicant, administrator and fiduciary agent for the ARRA JAG program; and

**WHEREAS**, Resolution 0257-09 approved on April 7, 2009 established the necessary appropriations to administer the American Recovery and Reinvestment Act Justice Assistance Grant; and

**WHEREAS**, the Franklin County Prosecuting Attorney has reviewed the contracts and found them to be acceptable as to form.
