

Resolution authorizing the creation of the American Recovery and Reinvestment Act of 2009 – Franklin County Board of Developmental Disabilities (ARRA – FCBDD) Fund and Non-General Fund supplemental appropriations for stimulus funding received by Franklin County Board of Developmental Disabilities through the American Recovery and Reinvestment Act of 2009 (Board of Developmental Disabilities) (\$2,250,278.60)

WHEREAS, Franklin County Board of Developmental Disabilities (FCBDD) has received funding through the American Recovery and Reinvestment Act of 2009 (ARRA); and

WHEREAS, the stimulus funding provided through ARRA is reimbursing Franklin County Board of Developmental Disabilities for expenses that have been made through its Levy Fund (Fund 2022); and

WHEREAS, the FCBDD is expecting to receive \$2,211,580 for adult day services; and

WHEREAS, the FCBDD is also expecting to receive \$38,698.60 from the Ohio Department of Education; and

WHEREAS, the stimulus funding will be deposited into a new fund (Fund 2219) in order to maintain separate tracking of these dollars; and

WHEREAS, FCBDD has requested supplemental appropriations in the amount of \$2,250,278.60 in order to account for the reimbursed expenses within this new fund. This investment under the ARRA is estimated to create or retain approximately 24 jobs in Franklin County; now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

1. That the Board of Commissioners hereby authorizes the creation of the American Recovery and Reinvestment Act of 2009 – Franklin County Board of Developmental Disabilities (ARRA – FCBDD) Fund (Fund 2219) to be used by Franklin County Board of Developmental Disabilities in support of ARRA eligible activities.
