

Resolution approving a contract with the Columbus Police Department to participate on the 2009-2010 Countywide DUI Task Force (Sheriff)

WHEREAS, the mission of the Franklin County Sheriff's Office in part is to protect the lives and property of the citizens of Franklin County, to preserve the peace, and to prevent crime and disorder while constantly guarding personal liberties as prescribed by law; and

WHEREAS, to accomplish this mission, it is a goal of the Sheriff's Office to develop a strong, close working relationship with the Franklin County community; and

WHEREAS, on October 13, 2009, the Commissioners approved resolution 0805-09 allowing the Franklin County Sheriff's Office to continue as the lead agency/administrator for the Countywide DUI Task Force to help reduce alcohol related traffic accidents; and

WHEREAS, the Countywide DUI Task Force is paid through a grant offered by the Ohio Department of Public Safety, Ohio Traffic Safety Office; and

WHEREAS, with the same resolution, the Commissioners also approved contracts required by the state, with other law enforcement agencies that will be involved in the Countywide DUI Task Force; and

WHEREAS, since the passage of resolution 0805-09, one more entity has submitted a contract to join the Countywide DUI Task Force bringing the total 2009-2010 task force membership to 26; and

WHEREAS, the law enforcement agencies of the following entities desire to be involved in the Countywide DUI Task Force:

- 1) Columbus Police Department

WHEREAS, the contracts shall be in full force until September 30, 2010 and shall not exceed the total allowable grant expenditures; and

WHEREAS, the Franklin County Sheriff's Office recognizes that the Franklin County Commissioners continue to support its current efforts, and requests further support of the Countywide DUI Task Force; and

WHEREAS, the Franklin County Sheriff's Office recommends that the Franklin County Commissioners approve the attached contract of the participating agency in the Countywide DUI Task Force paid through a grant offered by the Ohio Department of Public Safety, Ohio Traffic Safety Office and administered by the Franklin County Sheriff's Office

WHEREAS, with passage of this resolution, the Franklin County Commissioners authorize the County Administrator to sign the participant contract on their behalf; and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

- 1) That the attached Countywide DUI Task Force contract is hereby approved.
