

**Resolution authorizing the renewal of the Recorder's Equipment Fund  
(Commissioners)**

**WHEREAS**, section 317.321 of the Ohio Revised Code authorizes the County Recorder to request that the County Commissioners set aside an amount not to exceed \$4.00 from specific transactions in a special fund for the acquisition or maintenance of equipment for the Recorder's Office; and

**WHEREAS**, the Franklin County Commissioners have set aside \$2.00 from specific transactions as previously authorized in Resolution 1170-93, which was most recently renewed in Resolution 1041-07 for an additional two years until December 31, 2009; and

**WHEREAS**, the \$2.00 fee set aside has been deposited to the credit of the Recorder's Equipment Fund (Fund 2016); and

**WHEREAS**, the Franklin County Recorder has requested that the Franklin County Commissioners continue to set aside \$2.00 from specific transactions for two additional years to be deposited to the credit of the Recorder's Equipment Fund; and

**WHEREAS**, the request from the Franklin County Recorder has been received and entered on the Journal by the Clerk; and

**WHEREAS**, pursuant to section 317.321 of the Ohio Revised Code, the Franklin County Commissioners have determined that a two-year extension through December 31, 2011 is appropriate given the projected revenues and expenditures within the Recorder's Equipment Fund, and

**WHEREAS**, the Franklin County Commissioners believe that the request is necessary to preserve and protect the public records recorded in the Office of the Franklin County Recorder now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

1. That pursuant to division (A)(1) of section 317.321 of the Ohio Revised Code, \$2.00 of the fee collected for filing or recording a document for which a fee is charged as required by division (A) of section 317.32, section 1309.525, or section 5310.15 of the Ohio Revised Code shall be deposited to the credit of the Recorder's Equipment Fund (Fund 2016), and;

2. That the deposit of the \$2.00 fee into the Recorder's Equipment Fund shall continue for two additional years for the renewed period commencing January 1, 2010 through December 31, 2011, and;
3. That expenditures from the Recorder's Equipment Fund (Fund 2016) shall include equipment purchases or maintenance for the Recorder's Office and the Microfilming Center, and;
4. That expenditures from the Recorder's Equipment Fund (Fund 2016) shall be subject to appropriation and approval of purchase orders by the Board of County Commissioners.
