

**Resolution approving the amendment of nine contracts for Title XX services. (Department of Job and Family Services – Increase \$1,163,785.29) (\$2,627,202.05)**

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into contracts with public and private organizations for the purchase of Title XX services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, the Franklin County Department of Job and Family Services proposes to enter into contracts with Catholic Social Services; Cerebral Palsy, Inc.; Deaf Services Center; Franklin County Probate Court; Heritage Day Health Centers; Isabelle Ridgway Nursing Center; LifeCare Alliance; Ohio Presbyterian Retirement Service dba Senior Independence (Home Based Services); and Ohio Presbyterian Retirement Service dba Senior Independence (Home Health Aide) to provide Title XX social services to eligible individuals; and

**WHEREAS**, resolution number 549-09 included contracts with nine agencies to provide Congregate Meals, Day Care for Adults, Home Health Aide Services, Home Based Services, Home Delivered Meals, Legal Services, Special Services for Persons with Developmental or Physical Disabilities or Persons with Visual or Auditory Impairments, and Transportation Services for the time period of July 1, 2009 through June 30, 2010; and

**WHEREAS**, the parties desire to extend the terms of the nine contracts from June 30, 2010 to September 30, 2010 and increase the amount contracted by \$1,163,785.29 for a new total contracted amount of \$2,627,202.05; and

**WHEREAS**, the Franklin County Department of Job and Family Services proposes to purchase Title XX social services from Catholic Social Services; Cerebral Palsy, Inc.; Deaf Services Center; Franklin County Probate Court; Heritage Day Health Centers; Isabelle Ridgway Nursing Center; LifeCare Alliance; Ohio Presbyterian Retirement Service dba Senior Independence (Home Based Services); and Ohio Presbyterian

Retirement Service dba Senior Independence (Home Health Aide) for the time period of July 1, 2009 through September 30, 2010 for a total dollar value of \$2,627,202.05;
