

Resolution approving eight subaward agreements for Refugee Employability Programs (Department of Job and Family Services) (\$ 2,502,298.49)

WHEREAS, the Franklin County Department of Job and Family Services is authorized to enter into subaward agreements with public and private organizations for the purchase of TANF, Refugee Social Services and Targeted Assistance Grant services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to enter into eight subaward agreements with Community Refugee and Immigration Services (3), Eastland-Fairfield Career & Technical School, Ethiopian Tewahedo Social Services (2), Jewish Family Services and Somali Bantu Community Association for refugee employability programs; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to purchase refugee employability programs from Community Refugee and Immigration Services, Eastland-Fairfield Career & Technical School, Ethiopian Tewahedo Social Services, Jewish Family Services and Somali Bantu Community Association for the time period of July 1, 2010 through September 30, 2011 for a total dollar value of \$ 2,502,298.49;

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

That the attached purchase order \$254,971.21 for Community Refugee and Immigration Services (25-11-1004), \$119,432.84 for Community Refugee and Immigration Services (25-11-1003), \$135,698.19 for Community Refugee and Immigration Services (25-11-1005), \$57,507.17 for Eastland-Fairfield Career & Technical Schools, \$179,470.09 for Ethiopian Tewahedo Social Services (25-11-1007), \$222,210.79 for Ethiopian Tewahedo Social Services (25-11-1006), \$173,515.66 for Jewish Family Services, and \$108,344.08 for Somali Bantu Community Association for the remainder of 2010 and the Delegation of Authority as specified in Resolution No. 229-08 are hereby approved in the amount listed.
