

Resolution authorizing the Agreement with Pay Gov, LLC and TransFirst Health and Government Services, LLC to process credit cards used for filing fees due the County.

WHEREAS, the Board of Commissioners, on behalf of the Clerk of the Franklin County Courts of Common Pleas authorized the acceptance of financial transaction devices (as defined in Section 301.28 of the Ohio Revised Code) under Resolution No. 317-07, as approved by the Board of Commissioners on April 24, 2007.

WHEREAS, in accordance with the authority granted under Resolution No. 317-07, the County established a process for the acceptance of financial transaction devices.

WHEREAS, as provided for in Section 301.28 of the Ohio Revised Code, any office of the Clerk of Courts of Common Pleas that accepted financial transaction devices on or before July 1, 1999 may continue to accept such devices without being subject to any resolution passed by the County.

WHEREAS, the Board of Commissioners, on behalf of the Clerk of the Franklin County Courts of Common Pleas authorized the use of Frontline Processing Corp. to provide a credit card payment system for the Franklin County Clerk of Courts Auto Title Divisions under Resolution 75-09, as approved by the Board of Commissioners on February 3, 2009 and modified and extended under Resolution 359-10, as approved by the Board of Commissioners on May 4, 2010; and thereafter amended and restated under an Amended and Restated Agreement (the "Amended Agreement") approved by the Board of Commissioners under Resolution #209-11 dated April 19, 2011 and assigned under a certain Assignment and Assumption Agreement by and among Pay Gov LLC, Frontline Processing and TransFirst Health and Governance Services, LLC, as approved under Resolution #210-11 dated April 26, 2011;

WHEREAS, the eGovernance Board recommends approval to the Board of Commissioners of (a) the Agreement with Pay Gov, LLC and TransFirst Health and Governance Services, LLC, in order to expand the County's program to process the payment of expenses related to legal
