

Resolution authorizing a settlement to Richard Link for a disputed vehicle damage claim due to an auto accident involving a Franklin County Sheriff's Deputy (Sheriff) (\$1,000)

WHEREAS, on March 17, 2011, Franklin County Sheriff's Deputy Brian Ary was involved in an auto accident; and

WHEREAS, a vehicle, owned by Richard Link was struck in the driver side front fender when a civil vehicle traveling west on Jackson Street failed to stop at a stop sign; and

WHEREAS, both vehicles sustained damage in the accident, and no injuries were reported at the time of the accident; and

WHEREAS, Franklin County will pay Richard Link's insurance deductible in the amount of One Thousand Dollars (\$1,000) for the damages done to his vehicle in the accident that occurred on March 17, 2011; and Richard Link has accepted contingent on approval by the Commissioners; and

WHEREAS, the above described settlement fairly compensates Richard Link for the damages to his vehicle; and

WHEREAS, by agreeing to this settlement, neither Deputy Brian Ary, the Franklin County Commissioners, nor the Franklin County Sheriff's Office admits to any negligence or liability arising out of the auto accident; and

WHEREAS, the above described settlement, recommended by Franklin County Fleet Management and the Prosecuting Attorney's Office deems it to be in the best interest of the Franklin County Commissioners and the Franklin County Sheriff's Office to settle the vehicle claim for One Thousand Dollars (\$1,000); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of One Thousand Dollars (\$1,000) is in the best interest of the Franklin County Commissioners, Franklin County Sheriff's Office, and the Department of Fleet Management and the same is hereby approved.

That upon execution of a full release in favor of the Franklin County Commissioners, Department of Fleet Management, and the Franklin County Sheriff's Office that is satisfactory to the Prosecutor's Office; a warrant be issued payable to Richard Link, and forwarded to 5959 Luccis Court, Columbus, Ohio 43228 as full and final settlement of this matter.
3. The attached Purchase Order in the amount of One Thousand Dollars (\$1,000) is hereby approved.
