

**Resolution approving amendments to ten subaward agreements for Youth After School Programs (Department of Job and Family Services, an increase of \$1,116,443.41) (\$2,300,477.41)**

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into contracts with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Resolution Number 0703-10 authorized the Franklin County Department of Job and Family Services to enter into subaward agreements for Youth After School Programs with Clintonville Beechwood Community Resources Center, Godman Guild Association (25-11-6007), Henkels & McCoy Inc, J. Ashburn Jr. Youth Center, St, Stephen's Community Services, and the YMCA of Central Ohio for the time period of September 15, 2010 through August 31, 2011 for a total dollar value of \$547,603.23; and

**WHEREAS**, Resolution Number 0738-10 authorized the Franklin County Department of Job and Family Services to enter into subaward agreements for Youth After School Programs with Easter Seals Central and Southeast Ohio and Godman Guild Association (25-11-6013) for the time period of September 28, 2010 through August 31, 2011 for a total dollar value of \$452,050.75; and

**WHEREAS**, Resolution Number 0752-10 authorized the Franklin County Department of Job and Family Services to enter into subaward agreements for Youth After School Programs with Columbus Housing Partnership and EnterpriseWorks for the time period of October 5, 2010 through August 31, 2011 for a total dollar value of \$272,275.71; and

**WHEREAS**, Resolution 229-08, assigned the Director of the Franklin County Department of Job and Family Services the specific Delegation of Authority to approve certain contract amendments, pursuant to Ohio Revised Code 329.04. Under that authority the subaward agreements with Easter Seals Central and Southeast Ohio, Godman Guild Association (11-25-6007), Godman Guild Association (11-25-6013), Henkels & McCoy, and the YMCA of Central Ohio were amended to adjust the units of service

and decrease the subaward amounts by \$87,896.30 for an amended total amount of \$ 673,137.86; and

**WHEREAS**, the parties desire to amend the terms of the subaward agreements with Clintonville Beechwold Community Resources Center, Columbus Housing Partnership, Easter Seals Central and Southeast Ohio, EnterpriseWorks, Godman Guild Association (25-11-6007), Godman Guild Association (25-11-6013), Henkels & McCoy Inc, J. Ashburn Jr. Youth Center, St, Stephen’s Community Services, and the YMCA of Central Ohio, to include funding for back to school supplies and vouchers; increase the amount by \$ \$1,116,443.41 for an amended total amount of \$2,300,477.41 and extend the expiration date from August 31, 2011 to August 31, 2012
