

Resolution approving amendments to three contracts with Access 2 Interpreters (2) and Community Refugee and Immigration Services for Interpretation and Translation services (Department of Job and Family Services, an increase of \$820,969.76) (\$1,653,733.45)

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into contracts with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Resolution Number 0467-10 authorized the Franklin County Department of Job and Family Services to enter into a contract with Access 2 Interpreters for interpretation services for the time period of June 9, 2010 through September 30, 2011 for a total dollar value of \$581,608.12; and

**WHEREAS**, Resolution Number 0522-10 authorized the Franklin County Department of Job and Family Services to enter into contracts with Access 2 Interpreters for the purchase of translation services for the period of July 7, 2010 through September 30, 2011, in the amount of \$24,088.57; and with Community Refugee and Immigration Services for the purchase of interpretation services for the period of July 1, 2010 through September 30, 2011 in the amount of \$227,067.00; and

**WHEREAS**, the parties desire to retain the terms of the contracts with Access 2 Interpreters (2) and Community Refugee and Immigration Services; increase the amount by \$ 820,969.76 for an amended total amount of \$1,653,733.45 and extend the expiration date from September 30, 2011 to September 30, 2012

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

That the attached purchase order for the remainder of 2011 and the Delegation of Authority as specified in Resolution No. 229-08 are hereby approved in the amount listed.
