

Resolution authorizing a settlement to Conner Campassi for a vehicle damage claim sustained in a motor vehicle accident involving an employee of the Board of Franklin County Commissioners, Public Facilities Management (Public Facilities Management) (\$691.47)

WHEREAS, on August 9, 2011, Mr. Michael Hepp, an employee of the Board of Franklin County Commissioners, Public Facilities Management, was involved in a motor vehicle accident; and

WHEREAS, while exiting from the Mound & Fulton Streets parking garage located at 34 East Fulton Street, a vehicle, owned and driven by Mr. Conner Campassi sustained damage when struck by Mr. Hepp as he backed out of his parking space; and

WHEREAS, while both vehicles sustained damage, no injuries to any drivers or passengers were reported at the time of the accident; and

WHEREAS, this action would authorize payment by Franklin County to Mr. Campassi in the amount of Six Hundred Ninety-One Dollars and Forty-Seven Cents (\$691.47) for repair of the damages to his vehicle (\$500.00) and for non-reimbursed rental car coverage (\$191.47), and Mr. Campassi has agreed to accept payment contingent upon approval by Franklin County; and

WHEREAS, the above described settlement fairly compensates Mr. Campassi for the repair of the damages to his vehicle; and

WHEREAS, by agreeing to this settlement, neither Mr. Hepp, nor the Franklin County Commissioners, admits to any negligence or liability arising out of the accident; and

WHEREAS, the settlement, recommended by Franklin County Fleet Management and the Franklin County Prosecuting Attorney deem it to be in the best interest of the Franklin County Commissioners to settle the claim for Six Hundred Ninety-One Dollars and Forty-Seven Cents (\$691.47); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above referenced settlement in the amount of \$691.47 is in the best interest of the Franklin County Commissioners and the Franklin County Department of Fleet Management and the same is hereby approved.
2. That upon execution of a full release in favor of the Franklin County Commissioners that is satisfactory to the Franklin County Prosecuting
