

Resolution authorizing the Franklin County Board of Commissioners to accept the Collective Bargaining Agreement between the Franklin County Clerk of Courts Office and AFSCME Ohio Council 8, AFL-CIO, Local 615 (Clerk of Courts)

WHEREAS, the Franklin County Clerk of Courts Office and AFSCME Ohio Council 8, AFL-CIO, Local 615 ("AFSCME") representing all account clerks, account technicians, customer service clerks 1 and 2, data clerks 1 and 2, liaison clerks, mail clerks, microfiche scanners and records clerks 1 and 2 within the Clerk of Courts Office, but excluding all Auto title employees, have engaged in collective bargaining negotiations pursuant to Chapter 4117 of the Ohio Revised Code regarding a new contract to be effective until December 31, 2013.

WHEREAS, the agreement pertaining to wages provides a base wage increase of one and one-half percent (1.5%) retroactive to January 1, 2011; one percent (1%) base wage increase effective January 1, 2012; and one percent (1%) base wage increase effective January 1, 2013.

WHEREAS, the agreement pertaining to health insurance benefits provides that employees who seek participation in the Franklin County health insurance plan and shall pay a monthly premium in 2011 in the amount of Sixty Dollars (\$60) to cover themselves and any dependent children and One Hundred Sixty Dollars (\$160) to cover a spouse. Effective January 1, 2012, employees who seek participation in the Franklin County health insurance plan shall pay a monthly premium in the amount of One Hundred Five Dollars (\$105) to cover themselves and any dependent children and Two Hundred Twenty Five Dollars (\$225) to cover a spouse. Effective January 1, 2013, employees who seek participation in the Franklin County health insurance plan shall pay a monthly premium in the amount of One Hundred Ten Dollars (\$110) to cover themselves and any dependent children and Two Hundred Thirty Dollars (\$230) to cover a spouse.

WHEREAS, the Franklin County Board of Commissioners have reviewed the Agreement between the Franklin County Clerk of Courts Office and AFSCME; now, therefore,
