

**Resolution authorizing a settlement to Jeffery Bellamy for a disputed vehicle damage claim due to an auto accident involving a Franklin County Sheriff's Deputy (Sheriff) (\$4,317.56)**

**WHEREAS**, on August 26, 2011, Franklin County Sheriff's Lieutenant Michael Harrow was involved in an auto accident; and

**WHEREAS**, a vehicle, owned by Jeffery Bellamy, operated by his daughter, Marissa Bellamy, was struck when a patrol vehicle traveling east on US 40 failed to change lanes with caution; and

**WHEREAS**, both vehicles sustained damage in the accident, and injuries were reported at the time of the accident; and

**WHEREAS**, Franklin County will pay Jeffery Bellamy in the amount of Four Thousand Three Hundred Seventeen Dollars and Fifty Six Cents (\$4,317.56) for the damages done to his vehicle in the accident that occurred on August 26, 2011; and Jeffery Bellamy has accepted contingent on approval by the Commissioners; and

**WHEREAS**, the above described settlement fairly compensates Jeffery Bellamy for the damages to his vehicle; and

**WHEREAS**, by agreeing to this settlement, neither Lieutenant Michael Harrow, the Franklin County Commissioners, nor the Franklin County Sheriff's Office admits to any negligence or liability arising out of the auto accident; and

**WHEREAS**, the above described settlement, recommended by Franklin County Fleet Management, the Prosecuting Attorney's Office, and Rittel, Hill, and Zimmerman Insurance Services deems it to be in the best interest of the Franklin County Commissioners and the Franklin County Sheriff's Office to settle the vehicle claim for Four Thousand Three Hundred Seventeen Dollars and Fifty Six Cents (\$4,317.56); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of Four Thousand Three Hundred Seventeen Dollars and Fifty Six Cents (\$4,317.56) is in the best interest of the Franklin County Commissioners, Franklin County Sheriff's Office, and the Department of Fleet Management and the same is hereby approved.

That upon execution of a full release in favor of the Franklin County Commissioners, Department of Fleet Management, and the Franklin County Sheriff's Office that is satisfactory to the Prosecutor's Office; a warrant be issued payable to Jeffery Bellamy, and forwarded to 5264 Big Run South Road, Grove City, Ohio 43123 as full and final settlement of this matter.
