

**Resolution approving fifty-seven contract extensions for Senior Options Home Care**

(Office on Aging)

(ESTIMATED ANNUAL DOLLAR VALUE \$16,298,165.00)

**WHEREAS**, the Franklin County Office on Aging administers Franklin County Senior Options which is a consumer-focused system of care that provides services for the elderly and is funded by the Senior Services Levy; and

**WHEREAS**, the provider agencies listed below were awarded purchase of service agreements pursuant to a competitive bidding process undertaken by the Franklin County Purchasing Department and the Franklin County Office on Aging (ITB# 2009-11-32); and

**WHEREAS**, the original agreement allows for two optional one-year extensions, with this being the second and final extension, allowing a 1% price increase at each extension;

**WHEREAS**, the Franklin County Office on Aging and the providers listed below have agreed to this second and final extension of the original agreement for the period October 1, 2011 through September 30, 2012 with the same terms and conditions and at the pricing listed below; and

**WHEREAS**, the Franklin County Office on Aging recommends that the agreement extensions with the providers below be approved for the period of October 1, 2011 through September 30, 2012.

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:
