

**Resolution authorizing a police services agreement to fingerprint, photograph, and collect DNA from individuals arrested in the Franklin County Courthouse for the City of Columbus (Sheriff)(\$7,500)**

**WHEREAS**, Ohio Revised Code, Section 109.60 requires fingerprinting of individuals upon arrest; and

**WHEREAS**, Ohio Revised Code, Section 2901.07 requires that persons arrested after July 1, 2011, who are eighteen years of age or older and who are arrested for a felony offense, submit to a DNA specimen collection procedure; and

**WHEREAS**, the City of Columbus, through its Department of Public Safety, wishes to enter into an agreement with the Sheriff for him to provide fingerprinting, photograph, and DNA collection services, including palm prints, of individuals who are arrested in the Franklin County Courthouse by the Columbus Police Department's Court Liaison Officers; and

**WHEREAS**, invoicing will only occur when the arrested individuals are charged solely under the Ohio Revised Code and not the City of Columbus Code; and

**WHEREAS**, in exchange for said services, the City shall pay the Sheriff an amount not to exceed thirty-five dollars (\$35) per prisoner who is fingerprinted and photographed, and an amount not to exceed fifteen dollars (\$15) per prisoner who, in addition to being fingerprinted and photographed, has a DNA specimen collected; and

**WHEREAS**, the attached agreement will replace a contract currently in place approved on 5/31/11 by resolution 352-11; and

**WHEREAS**, the term of this agreement shall commence on March 13, 2012; and shall continue to be in force for one year. Unless otherwise terminated as provided in the contract, this agreement shall automatically renew for a twelve month period on March 13, 2013; and

**WHEREAS**, total compensation to the Sheriff under this agreement shall not exceed seven thousand five hundred dollars (\$7,500) for the 24-month period; and

**WHEREAS**, the Sheriff is authorized to enter into an agreement with the City for the performance of police functions, as set forth in Ohio Revised Code sections 311.29 and 737.04; and

**WHEREAS**, the Franklin County Sheriff's Office recommends that the Franklin County Commissioners authorize this contract to further guarantee that arrested individuals are properly identified and accounted for and to increase the revenue generated for the county general fund; and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

- 1) That the attached contract with the City of Columbus is hereby approved in the amount listed.
