

Resolution authorizing a settlement to William Mahaffey II for a disputed vehicle damage claim due to an auto accident involving a Franklin County Dog Shelter Warden (Dog Shelter & Adoption Center) (\$200.00)

WHEREAS, on February 25, 2012, Franklin County Dog Shelter and Adoption Center Warden, William Jones, was involved in an auto accident; and

WHEREAS, William Jones was patrolling a Hamilton Twp. Park off Lockbourne Road at the entrance/exit to Edgeview; and

WHEREAS, William Mahaffey II, drove into the parking lot and legally parked. Mr. Jones backed up and ran into Mr. Mahaffey's vehicle; and

WHEREAS, Mr. Mahaffey's vehicle sustained damage in the accident, but no injuries were reported; and

WHEREAS, Franklin County will pay the insurance deductible of two hundred 00/100 dollars (\$200.00) as allowed by the Ohio Revised Code to Mr. Mahaffey for damages to his vehicle in the accident that occurred on February 25, 2012; and Mr. Mahaffey has accepted contingent on approval by the Commissioners; and

WHEREAS, the above described settlement fairly compensates Mr. Mahaffey for the damages to his vehicle; and

WHEREAS, by agreeing to this settlement, neither William Jones, the Franklin County Commissioners, nor the Franklin County Dog Shelter and Adoption Center admits to any negligence or liability out of the auto accident; and

WHEREAS, the above described settlement, recommended by Franklin County Fleet Management, and the Prosecuting Attorney's Office, deems it to be in the best interest of the Franklin County Board of Commissioners and the Franklin County Dog Shelter and Adoption Center to settle the vehicle claim for two hundred 00/100 dollars (\$200.00); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of two hundred 00/100 dollars (\$200.00) is in the best interest of the Franklin County Commissioners, Franklin County Dog Shelter & Adoption Center and the Department of Fleet Management and the same is hereby approved.
2. That upon execution of a full release in favor of the Franklin County Commissioners and Department of Fleet Management that is satisfactory to the Prosecutor's Office; a warrant be issued payable to William Mahaffey II, and forwarded to 812 Breathitt Avenue, Columbus, OH 43207 as full and final settlement of this matter.
3. The attached Purchase Order in the amount of two hundred 00/100 dollars (\$200.00) is hereby approved.
