

Resolution authorizing a settlement of a disputed claim for bodily injury to Mr. Jason Brabham Sr. due to an auto accident involving Franklin County Veterans Service Commission (Veterans Service Commission) (\$5,500)

WHEREAS, on January 25, 2011, Franklin County Veterans Service Commission employee Mr. Barry J. Roberts, was involved in an auto accident; and

WHEREAS, Mr. Barry J. Roberts was traveling westbound on E. Fulton Street and was turning into a parking lot on E. Fulton Street when he failed to turn wide enough and struck a car owned by Nicole Williams that was parked at a meter; and

WHEREAS, Mr. Jason Brabham Sr. was a passenger in the parked vehicle Mr. Barry J. Roberts hit; and

WHEREAS, settlement in the amount of five thousand five hundred and 00/100 dollars (\$5,500.00) has been negotiated and recommended by the claim analyst for the Board of Commissioners of Franklin County Ohio, Rittel, Hill and Zimmerman; and

WHEREAS, Franklin County offered to pay five thousand five hundred and 00/100 dollars (\$5,500.00) to Mr. Jason Brabham Sr. for injuries he suffered in the accident that occurred on January 25, 2011; and Mr. Jason Brabham Sr. has accepted contingent on approval by the Commissioners; and

WHEREAS, the above described settlement fairly compensates Mr. Jason Brabham Sr. for his injuries; and

WHEREAS, by agreeing to this settlement, neither Mr. Barry J. Roberts, the Franklin County Commissioners, nor the Franklin County Veterans Service Commission admits to any negligence or liability arising out of the auto accident; and

WHEREAS, the above described settlement, recommended by Rittel, Hill and Zimmerman deems it to be in the best interest of the Franklin County Board of Commissioners and the Franklin County Veterans Service Commission to settle the injury claim for five thousand five hundred and 00/100 dollars (\$5,500.00); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of five thousand five hundred and 00/100 dollars (\$5,500.00) is in the best interest of the Franklin County Commissioners, Franklin County Veterans Service Commission and the Department of Fleet Management and the same is hereby approved.
2. That upon execution of a full release in favor of the Franklin County Commissioners, Department of Fleet Management and the Franklin County Veterans Service Commission that is satisfactory to the Prosecutor's Office; the warrant will be issued payable to Mr. Jason Brabham Sr. and Karr & Sherman Co., LPA and forwarded to Rittel, Hill and Zimmerman at 4920 Reed Rd Unit E, Columbus, Oh 43220-3154 in exchange for Mr. Jason Brabham Sr. signed release and as full and final settlement of this matter.
3. The attached Purchase Order in the amount of five thousand five hundred and 00/100 dollars (\$5,500.00) is hereby approved.
