

Resolution approving amendments to three contracts with Access 2 Interpreters (2) and Community Refugee and Immigration Services for Interpretation and Translation services (Department of Job and Family Services, an increase of \$812,500.00) (\$2,466,233.45)

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into contracts with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Resolution Number 0467-10 authorized the Franklin County Department of Job and Family Services to enter into a contract with Access 2 Interpreters for interpretation services for the time period of June 9, 2010 through September 30, 2011 for a total dollar value of \$581,608.12; and

**WHEREAS**, Resolution Number 0522-10 authorized the Franklin County Department of Job and Family Services to enter into contracts with Access 2 Interpreters for the purchase of translation services for the period of July 7, 2010 through September 30, 2011, in the amount of \$24,088.57; and with Community Refugee and Immigration Services for the purchase of interpretation services for the period of July 1, 2010 through September 30, 2011 in the amount of \$227,067.00; and

**WHEREAS**, Pursuant to Resolution 229-08, which authorizes the Director of Franklin County Department of Job and Family Services to amend certain contracts, the contract with Community Refugee and Immigration Services was reduced by \$50,000.00 on October 13, 2010 for a new contract amount of \$227,067.00

**WHEREAS**, Resolution Number 0658-11 amended contracts with Access 2 Interpreters for interpretation services for the period of October 1, 2011 through September 30, 2012 in the amount of \$608,274.47, and for translation services for the period of October 1, 2011 through September 30, 2012 in the amount of \$18,066.43; The resolution also amended the contract with Community Refugee Services for interpretation services for the period of October 1, 2011 through September 30, 2012 in the amount of \$194,628.86; and
