

Resolution approving ten (10) subaward agreements for Youth Afterschool Programs (Department of Job and Family Services) (\$ 839,968.44)

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into subaward agreements with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, the Franklin County Department of Job and Family Services proposes to enter into 10 subaward agreements with Clintonville Beechwold Community Resources Center, Columbus Housing Partnership, Easter Seals Central & Southeast Ohio, Enterprise Works, Godman Guild Association (2), Henkels & McCoy, J. Ashburn Jr. Youth Center, St. Stephen's Community Services Inc, and the YMCA of Central Ohio for afterschool programs; and
