

**Report (4th), establishing sums of compensation and damages for a portion of the owners on the Refugee Road – Chatterton Road at Noe-Bixby Road project, Truro Township, Franklin County, Ohio (Engineer) (\$52,511.00)**

**WHEREAS**, the Board of County Commissioners did by resolution duly adopted find in favor of improving Refugee Road – Chatterton Road at Noe-Bixby, Truro Township, Franklin County, Ohio; and

**WHEREAS**, the Franklin County Engineer has negotiated with a portion of the property owners abutting Refugee Road – Chatterton Road at Noe-Bixby Road; and

**WHEREAS**, the Franklin County Engineer is unable to acquire the property due to unsettled liens against the title and therefore recommends that appropriation proceedings be initiated for the acquisition of the below listed parcel(s) and recommends that the following amounts of compensation be awarded and deposited with the Clerk of the Common Pleas Court upon the filing of the appropriation case; and
