

Resolution authorizing a settlement to Jeanne Jonard for a disputed vehicle damage claim due to an auto accident involving a Franklin County Sheriff's Deputy (Sheriff) (\$250)

WHEREAS, on November 6, 2012, a Franklin County Sheriff's SIU Deputy was involved in an auto accident; and

WHEREAS, a stopped vehicle, owned by Jeanne Jonard was struck in the rear bumper by a SIU vehicle on an exit ramp leading to New Albany Road; and

WHEREAS, both vehicles sustained damage in the accident, and no injuries were reported at the time of the accident; and

WHEREAS, Franklin County will pay for the damage in the amount of Two Hundred Fifty Dollars (\$250) for the damages done to Jeanne Jonard's vehicle in the accident that occurred on November 6, 2012; and Jeanne Jonard has accepted contingent on approval by the Commissioners; and

WHEREAS, the above described settlement fairly compensates Jeanne Jonard for the damages to her vehicle; and

WHEREAS, by agreeing to this settlement, neither the SUI Deputy, the Franklin County Commissioners, nor the Franklin County Sheriff's Office admits to any negligence or liability arising out of the auto accident; and

WHEREAS, the above described settlement, recommended by Franklin County Fleet Management and the Prosecuting Attorney's Office deems it to be in the best interest of the Franklin County Commissioners and the Franklin County Sheriff's Office to settle the vehicle claim for Two Hundred Fifty Dollars (\$250); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of Two Hundred Fifty Dollars (\$250) is in the best interest of the Franklin County Commissioners, Franklin County Sheriff's Office, and the Department of Fleet Management and the same is hereby approved.

That upon execution of a full release in favor of the Franklin County Commissioners, Department of Fleet Management, and the Franklin County Sheriff's Office that is satisfactory to the Prosecutor's Office; a warrant be issued payable to Jeanne Jonard, and forwarded to 6008 Shala Circle, Nashport, Ohio 43830 as full and final settlement of this matter.
