

Resolution appointing members to the Family Services Planning Committee

**(COMMISSIONERS)**

**WHEREAS**, the Family Services Planning Committee (formerly named the Community Planning Committee) was established by the Franklin County Commissioners to meet the terms of Ohio Revised Code, Section 329.08 as it was enacted as part of HB 408, the welfare reform legislation enacted in 1997; and

**WHEREAS**, the Board shall appoint a representative of the County Department of Job & Family Services, an employee in the classified civil service of the County Department of Job & Family Services, and a member to represent the public; and

**WHEREAS**, the Board shall also appoint other individuals in such a manner that the committee's membership is broadly representative of the groups of individuals and the public and private entities that have an interest in the family services provided in the County in a manner that reflects the ethnic and racial composition of the County; and

**WHEREAS**, the Family Services Planning Committee serves as an advisory body to the Board of County Commissioners with regard to the family services provided in the County, including assistance under Chapters 5107 and 5108 of the ORC, publicly funded child care under Chapter 5104 of the ORC and social services provided under Section 5101.46 of the ORC; and

**WHEREAS**, at least once a year the Committee shall meet to review and analyze the County Department of Job & Family Services' implementation of the programs established under Chapters 5107 and 5108 of the Ohio Revised Code; now, therefore

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:
