

**Resolution approving a contract with Clinton Township, Mifflin Township, and Delaware County Sheriff's Office to participate on the 2012-2013 Countywide DUI Task Force (Sheriff)**

**WHEREAS**, the mission of the Franklin County Sheriff's Office in part is to protect the lives and property of the citizens of Franklin County, to preserve the peace, and to prevent crime and disorder while constantly guarding personal liberties as prescribed by law; and

**WHEREAS**, to accomplish this mission, it is a goal of the Franklin County Sheriff's Office to develop a strong, close working relationship with the Franklin County community; and

**WHEREAS**, on December 18, 2012, the Franklin County Commissioners approved resolution 0865-12 allowing the Franklin County Sheriff's Office to continue as the lead agency/administrator for the Countywide DUI Task Force to help reduce alcohol related traffic accidents; and

**WHEREAS**, the Countywide DUI Task Force is paid through a grant offered by the Ohio Department of Public Safety, Office of Criminal Justice Services; and

**WHEREAS**, with the same resolution, the Franklin County Commissioners also approved contracts required by the state, with other law enforcement agencies that will be involved in the Countywide DUI Task Force; and

**WHEREAS**, since the passage of resolution 0865-12, three more entities have submitted a contract to join the Countywide DUI Task Force bringing the total 2012-2013 task force membership to 24; and

**WHEREAS**, the law enforcement agencies of the following entities desire to be involved in the Countywide DUI Task Force:

- 1) Clinton Township
- 2) Mifflin Township
- 3) Delaware County Sheriff's Office

**WHEREAS**, the contracts shall be in full force until September 30, 2013 and shall not exceed the total allowable grant expenditures; and

**WHEREAS**, the Franklin County Sheriff's Office recognizes that the Franklin County Commissioners continue to support its current efforts, and requests further support of the Countywide DUI Task Force; and

**WHEREAS**, the Franklin County Sheriff's Office recommends that the Franklin County Commissioners approve the attached contracts of the participating agencies in the Countywide DUI Task Force paid through a grant offered by the Ohio Department of Public Safety, Office of Criminal Justice Services and administered by the Franklin County Sheriff's Office; and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

1. That the attached Countywide DUI Task Force contracts are hereby approved.
2. The Franklin County Commissioners hereby authorize the County Administrator pursuant to section 305.30 of the Ohio Revised Code to sign the Countywide DUI contracts of the aforementioned participating agencies.
