WHEREAS, the County wishes to modify the terms and conditions of the contract with LVI to provide additional Abatement and Selective Demolition Services for the Renovation and Redevelopment of the Franklin County Hall of Justice; and

WHEREAS, the County has allocated funds in the 2013 Budget specifically for this project; and

WHEREAS, the attached Contract Modification No. 003 (Franklin County PFM-MOD-430CM) executed by the County and LVI shall modify the governing contract, the terms and conditions of which are referenced and fully incorporated as if fully rewritten herein, and is binding on both parties; and

WHEREAS, Franklin County Public Facilities Management recommends the approval of Contract Modification No. 003 with LVI to provide additional Abatement and Selective Demolition Services associated with the Renovation and Redevelopment of the Franklin County Hall of Justice.
