

**Resolution approving one subaward agreement amendment with Jewish Family Services for Refugee Employability Programming (Department of Job and Family Services, increase of \$95,000.00) (\$1,717,879.43)**

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into subaward agreements with public and private organizations for the purchase of Refugee Social Services and Targeted Assistance Grant services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Resolution Number 0521-10 authorized the Franklin County Department of Job and Family Services to enter into a subaward agreement with Jewish Family Services for refugee employability programming for the time period of July 1, 2010 through September 30, 2011, for a total dollar value of \$347,031.33; and

**WHEREAS**, Resolution Number 0623-10 authorized the Franklin County Department of Job and Family Services to enter a subaward agreement by adding \$201,215.00 for the time period of July 1, 2010 through September 30, 2011, for a total dollar value of \$548,246.33; and

**WHEREAS**, Pursuant to the Ohio Revised Code 329.04 and Article III, Section D of the subaward agreement currently on file with FCDJFS, the Director of Franklin County Department of Job and Family Services has specific delegation of authority to directly execute extensions and renewals of subaward agreements. Under this authority, the original subaward with Jewish Family Services was amended by adding \$650,634.08, for a total dollar value of \$1,198,880.41, and extending the expiration date of the contract from September 30, 2011 to September 30, 2012; and

**WHEREAS**, Pursuant to the Ohio Revised Code 329.04 and Article III, Section D of the subaward agreement currently on file with FCDJFS, the Director of Franklin County Department of Job and Family Services has specific delegation of authority to directly execute extensions and renewals of subaward agreements. Under this authority, the subaward with Jewish Family Services was amended by adding \$423,999.02, for a total dollar value of \$1,622,879.43, and extending the expiration date of the contract from September 30, 2012 to September 30, 2013; and

**WHEREAS**, the parties desire to retain the terms of the subaward agreement with Jewish Family Services and increase the amount by \$95,000.00 for an amended total dollar value of \$1,717,879.43, for the time period ending September 30, 2013.
