

**Resolution authorizing miscellaneous appropriation adjustments.
(Domestic Relations)**

WHEREAS, the Division of Domestic Relations and Juvenile Branch of the Franklin County Court of Common Pleas has identified several appropriation adjustments needed to align program revenues and expenditures; and

WHEREAS, the Court has indicated that additional General Fund appropriations in the amount of \$11,431 are needed to partner with the United Way of Central Ohio in establishing the Restorative Justice Circles program; and

WHEREAS, the Court has also indicated that a non-general fund supplemental appropriation in the amount of \$25,000 is needed within the Special Foods Fund (Fund 2663), due to an increase in youth population at the Juvenile Detention Facility; and

WHEREAS, the Court has also indicated that a non-general fund supplemental appropriation, in the amount of \$2,775 is needed within the Drug Court Fund (Fund 2089), for a grant received from the Ohio Office of Criminal Justice Services; and

WHEREAS, the Court has requested a repayment of an interfund loan provided by the General Fund to the Drug Court Fund (Fund 2089) in the amount of \$15,267; now, therefore

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

1. That supplemental appropriations in the amount of \$27,775 are hereby authorized from the unappropriated cash balance as follows and allocated per the attached document (Journal #285):
