

Resolution approving one contract amendment with HandsOn Central Ohio for Title XX services (Department of Job and Family Services, an increase of \$492,704.04) (\$1,234,703.06)

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into contracts with public and private organizations for the purchase of Title XX and TANF-Transfer services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Resolution Number 0706-11 authorized the Franklin County Department of Job and Family Services to enter into contract with HandsOn Central Ohio for TANF-Transfer Services for the time period of October 1, 2011 through September 30, 2012 for a total dollar value of \$249,295.56; and

**WHEREAS**, Pursuant to the Ohio Revised Code 329.04 and Article III, Section D of the subaward agreement currently on file with FCDJFS, the Director of Franklin County Department of Job and Family Services has specific delegation of authority to directly execute extensions and renewals of contracts. Under this authority, the original contract with HandsOn Central Ohio was amended by adding \$119,997.84, for a total dollar value of \$369,293.40, and extending the expiration date of the contract from September 30, 2012 to September 30, 2013; and

**WHEREAS**, Resolution Number 0204-13 authorized the Franklin County Department of Job and Family Services to amend the contract with HandsOn Central Ohio for the time period of October 1, 2012 through September 30, 2013, by adding \$97,705.62 for an amended total dollar value of \$466,999.02; and

**WHEREAS**, Resolution Number 0578-13 authorized the Franklin County Department of Job and Family Services to amend the contract with HandsOn Central Ohio for the time period of October 1, 2012 through September 30, 2013, by adding \$275,000.00 for an amended total dollar value of \$741,999.02; and

**WHEREAS**, the parties desire to extend the terms of the contract with HandsOn Central Ohio by extending the expiration date from September 30, 2013 to September 30, 2014 and increase the amount by \$492,704.04 for an amended total dollar value of \$ 1,234,703.06.
