

Resolution reappointing Blake Bishop, Anne Dorrian Lenzotti, and Sadicka White to various Franklin County designated Tax Incentive Review Councils and Community Reinvestment Authorities

(COMMISSIONERS)

WHEREAS, pursuant to Ohio Revised Code Section 5709.85, a Tax Review Council ("TIRC") shall be established for every Community Reinvestment Area, Enterprise Zone and Tax Increment Finance District and that said TIRC's shall be composed of a minimum of seven (7) members whose purpose is to review and make recommendations to the Board of Commissioners in regard to agreements entered into as a result of the creation of these incentive programs; and

WHEREAS, pursuant to Ohio Revised Code Section 5709.85, the Franklin County Board of Commissioners shall appoint three (3) of the minimum seven (7) members of each TIRC; and

WHEREAS, the term of appointment to the designated Tax Incentive Review Councils and Community Reinvestment Authorities is set for a period of three (3) years; and

WHEREAS, the terms of Blake Bishop, Anne Dorrian Lenzotti and Sadicka White are due for reappointment; now, therefore

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:
