WHEREAS, the Board of Commissioners, Franklin County, Ohio ("County") wishes to secure additional Fire Protection Services associated with the Renovation and Redevelopment of the Franklin County Hall of Justice; and

WHEREAS, the County has entered into a contract with Dalmatian Fire, Inc. ("Dalmatian") to provide the Fire Protection Services associated with the Renovation and Redevelopment of the Franklin County Hall of Justice; and

WHEREAS, the County wishes to modify the terms and conditions of the contract with Dalmatian to provide additional Fire Protection Services for the Renovation and Redevelopment of the Franklin County Hall of Justice; and

WHEREAS, the County has allocated funds in the 2014 Budget specifically for this project; and

WHEREAS, the attached Contract Modification No. 003 (Franklin County PFM-MOD-430CM) executed by the County and Dalmatian shall modify the governing contract, the terms and conditions of which are referenced and fully incorporated as if fully rewritten herein, and is binding on both parties; and

WHEREAS, Franklin County Public Facilities Management recommends the approval of Contract Modification No. 003 with Dalmatian to provide additional Fire Protection Services associated with the Renovation and Redevelopment of the Franklin County Hall of Justice; now therefore

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, FRANKLIN COUNTY, OHIO;

That the attached Contract Modification No. 003 with Dalmatian Fire, Inc. in an amount not to exceed \$4,588.00 is hereby approved.
