

Resolution approving one contract amendment with Arbor E &T, LLC dba ResCare Workforce Services for the management of Franklin County Department of Job and Family Services Work Experience Program and the related participation (Department of Job and Family Services) (an increase of \$1,200,000.00) (\$10,255,456.45)

WHEREAS, the Franklin County Department of Job and Family Services is authorized to enter into contracts with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

WHEREAS, Resolution Number 0133-12 authorized the Franklin County Department of Job and Family Services to enter into contract with Arbor E&T, LLC, dba ResCare Workforce Services for the management of Franklin County Department of Job and Family Services' Work Experience Program and the related participation for the time period of February 14, 2012 through September 30, 2013 for a total dollar value of \$5,700,000.00; and

WHEREAS, Resolution Number 0269-13 authorized the Franklin County Department of Job and Family Services to amend the contract with Arbor E&T, LLC, dba ResCare Workforce Services by decreasing \$1,000,000.00, for an amended total dollar value of \$4,700,000.00, for the time period of February 14, 2012 through September 30, 2013; and

WHEREAS, Resolution Number 0585-13 authorized the Franklin County Department of Job and Family Services to amend the contract with Arbor E&T, LLC, dba ResCare Workforce Services by adding \$ 335,000.00, for an amended total dollar value of \$5,035,000.00, for the time period of February 14, 2012 through September 30, 2013; and

WHEREAS, Resolution Number 0754-13 authorized the Franklin County Department of Job and Family Services to amend the contract with Arbor E&T, LLC, dba ResCare Workforce Services by adding \$4,020,456.45, for an amended total dollar value of \$9,055,456.45.00, for the time period of February 14, 2012 through September 30, 2014
