

**Resolution authorizing a settlement to Connor Crawford for a disputed vehicle damage claim due to an auto accident involving a Franklin County Sheriff's Deputy (Sheriff) (\$500)**

**WHEREAS**, on May 2, 2014, a Franklin County Sheriff's Deputy was involved in an auto accident; and

**WHEREAS**, a vehicle, owned by Connor Crawford was struck in the rear end by a SIU vehicle in a parking lot off of East Main Street; and

**WHEREAS**, both vehicles sustained damage in the accident, injuries were not reported; and

**WHEREAS**, Franklin County will pay for the property damage in the amount of Five Hundred Dollars (\$500) for the damages done to Connor Crawford's vehicle in the accident that occurred on May 2, 2014; and Connor Crawford has accepted contingent on approval by the Commissioners; and

**WHEREAS**, the above described settlement fairly compensates Connor Crawford for the damages to his vehicle; and

**WHEREAS**, by agreeing to this settlement, neither the Deputy involved, the Franklin County Commissioners, nor the Franklin County Sheriff's Office admits to any negligence or liability arising out of the auto accident; and

**WHEREAS**, the above described settlement, recommended by Franklin County Fleet Management and the Prosecuting Attorney's Office deems it to be in the best interest of the Franklin County Commissioners and the Franklin County Sheriff's Office to settle the vehicle claim for Five Hundred Dollars (\$500); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of Five Hundred Dollars (\$500) is in the best interest of the Franklin County Commissioners, Franklin County Sheriff's Office, and the Department of Fleet Management and the same is hereby approved.
