

Resolution authorizing a contract agreement with Gandee & Associates, Inc. to provide Professional Engineering and Consulting Services: Decommissioning, Abatement, Demolition Design, and Planning Services for Franklin County Veterans Memorial.

WHEREAS, the Board of Commissioners, Franklin County, Ohio ("County") wishes to secure the services of a qualified firm to provide Professional Engineering and Consulting Services: Decommissioning, Abatement, Demolition Design, and Planning Services for Franklin County Veterans Memorial; and

WHEREAS, Gandee & Associates, Inc., submitted a response to Request for Qualifications No. 2014-03-04, and in its response and subsequent scope review sessions exhibited itself as qualified to provide the required scope of professional services; and

WHEREAS, the County has allocated funds in the 2014 Budget specifically for this project; and

WHEREAS, the term of the Contract shall be for the period beginning July 8, 2014, through completion; and

WHEREAS, the Franklin County Contract Form executed by the County and Gandee & Associates, Inc. shall be the governing contract which is fully incorporated herein, and is binding on both parties; and

WHEREAS, Franklin County Public Facilities Management recommends the approval of the Contract with Gandee & Associates, Inc. to provide Professional Engineering and Consulting Services: Decommissioning, Abatement, Demolition Design, and Planning Services for Franklin County Veterans Memorial.
