

Resolution authorizing contract extensions for Senior Options Home Care Services (Office On Aging) (Estimated annual contract amount \$12,250,000.00)

WHEREAS, contracts were awarded for Home Care Services on October 16, 2012 under Res. No. 0729-12 (ITB# 2012-11-08) for a period of two years with the option of two renewal periods; with the first optional renewal period being for two years and the second and final optional renewal period being for one year; and

WHEREAS, The Franklin County Office on Aging administers Franklin County Senior Options which is a consumer-focused system of care which is funded by the Senior Services levy with services including the following: Homemaker Services, Personal Care, Respite Care Services, Home Delivered Meals, Adult Day Care Services, and Emergency Response Systems; and

WHEREAS, the original contract allows for a 1% increase or decrease in rates with thirteen (13) agencies choosing the increase and the remainder chose to keep their rates the same. The rates will be firm and fixed throughout the contract extension period and under the same terms and conditions as originally bid; and

WHEREAS, the term of the contract extension will be effective beginning October 1, 2014 through September 30, 2016; and

WHEREAS, the Franklin County Office on Aging is satisfied with the services provided by the contractors and recommends the contract extensions with the contract agencies listed herein be approved for the period of October 1, 2014 through September 30, 2016, now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

That the attached extension contracts are hereby approved for the following sixty three (63) agencies as needed for services at the rates specified for the period of October 1, 2014 through September 30, 2016, and PO# 41101000-00 has been opened to encumber funds for the remainder of the year.
