

Resolution authorizing a settlement to John R. Dickey Jr. for a disputed vehicle damage claim due to an auto accident involving a Franklin County Sheriff's Deputy (Sheriff) (\$250)

WHEREAS, on October 27, 2014, Franklin County Sheriff's Deputy Brandon Walls was involved in an auto accident; and

WHEREAS, a stopped vehicle, owned by John R. Dickey Jr. and operated by a minor was struck in the rear by a Sheriff vehicle traveling southbound on Gender Road; and

WHEREAS, both vehicles sustained damage in the accident, and no injuries were reported; and

WHEREAS, Franklin County will pay for the damage in the amount of Two Hundred Fifty Dollars (\$250) for the damages done to John R. Dickey Jr's vehicle in the accident that occurred on October 27, 2014; and John R. Dickey Jr. has accepted contingent on approval by the Commissioners; and

WHEREAS, the above described settlement fairly compensates John R. Dickey Jr. for the damages to his vehicle; and

WHEREAS, by agreeing to this settlement, neither the Deputy Sheriff, the Franklin County Commissioners, nor the Franklin County Sheriff's Office admits to any negligence or liability arising out of the auto accident; and

WHEREAS, the above described settlement, recommended by Franklin County Fleet Management and the Prosecuting Attorney's Office deems it to be in the best interest of the Franklin County Commissioners and the Franklin County Sheriff's Office to settle the vehicle claim for Two Hundred Fifty Dollars (\$250); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of Two Hundred Fifty Dollars (\$250) is in the best interest of the Franklin County Commissioners, Franklin County Sheriff's Office, and the Department of Fleet Management and the same is hereby approved.
