

**Establishing, altering and widening of Demorest Road between Clime Road and Briggs Road, Franklin Township, Franklin County, Ohio, viewed – Engineer to file plans as necessary (Engineer)**

**WHEREAS**, on August 5, 2014, the Board of County Commissioners of Franklin County, Ohio, adopted a resolution declaring it necessary to establish, alter and widen Demorest Road between Clime Road and Briggs Road, Franklin Township, Franklin County, Ohio; and

**WHEREAS**, on August 5, 2014, said Board of County Commissioners did fix the 19<sup>th</sup> day of August, 2014 on the line of said proposed improvement as the time and place for the viewing thereof; and

**WHEREAS**, the viewing was rescheduled to Wednesday, November 26, 2014; and

**WHEREAS**, legal notice was published in a newspaper of general circulation in said County and was given of the time and place for the viewing of said establishing, altering and widening, and of the final hearing thereof; and

**WHEREAS**, the Board of County Commissioners of Franklin County, Ohio did on the 26<sup>th</sup> day of November, 2014 view said proposed establishing, altering and widening of Demorest Road between Clime Road and Briggs Road, meet on the line thereof as described in previous resolution declaring the project necessary, and heard all the proof offered by parties interested in the affected thereby and other persons competent to testify, and did go over and along the line of said proposed improvement and the premises adjacent thereto, which are to be affected thereby and does find that the establishing, altering and widening of Demorest Road between Clime Road and Briggs Road is of sufficient importance to require that the Engineer of Franklin County, Ohio be instructed and directed to make a survey and plat; now, therefore,

BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF FRANKLIN COUNTY, OHIO:

Section 1) That the Engineer of Franklin County, Ohio is hereby authorized and instructed to (1) make a survey and plat of the proposed establishing, altering and widening of Demorest Road between Clime Road and Briggs Road, (2) make an accurate and detailed description of each tract of land which will be needed for the project, together with the names of each owner, (3) set stakes at the termini of each right of way line and at all angles between such termini and at sufficient other points in the

right of way lines so that the bounds of the proposed road improvement may be discernible to the property owners and others interested, and (4) make report to the Board of County Commissioners. Said report shall set forth the opinion of the County Engineer either for or against the granting of said improvement; and the report, together with the survey and plat of the proposed improvement, is to be deposited with the County Commissioners.

Section 2) That the Franklin County Engineer, by his request, is hereby authorized and directed to investigate and recommend to this Board a consulting engineer to be employed to assist him in the preparation of plans and all other related documents for the above mentioned improvement.

Section 3) That the County Engineer is hereby empowered and directed on behalf of the County to enter into agreements as necessary to complete the planning, design and construction of this improvement.
