

**Resolution authorizing a settlement to Kyle Degoey for a disputed property damage claim due to an auto accident involving a Franklin County Sheriff's Deputy (Sheriff) (\$1,000)**

**WHEREAS**, on April 1, 2015, Franklin County Sheriff Deputy Bill Ihrig was involved in an auto accident; and

**WHEREAS**, a US Protection Service vehicle, owned by Kyle Degoey was struck by a Patrol vehicle on Buckeye Circle; and

**WHEREAS**, both vehicles sustained damage in the accident, injuries were not reported; and

**WHEREAS**, Franklin County will pay for the property damage in the amount of One Thousand Dollars (\$1,000) for the damages done to Kyle Degoey's vehicle in the accident that occurred on April 1, 2015; and Kyle Degoey has accepted contingent on approval by the Commissioners; and

**WHEREAS**, the above described settlement fairly compensates Kyle Degoey for the damages to his vehicle; and

**WHEREAS**, by agreeing to this settlement, neither Deputy Bill Ihrig, the Franklin County Commissioners, nor the Franklin County Sheriff's Office admits to any negligence or liability arising out of the auto accident; and

**WHEREAS**, the above described settlement, recommended by Franklin County Fleet Management and the Prosecuting Attorney's Office deems it to be in the best interest of the Franklin County Commissioners and the Franklin County Sheriff's Office to settle the property damage claim for One Thousand Dollars (\$1,000); and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the above-referenced settlement in the amount of One Thousand Dollars (\$1,000) is in the best interest of the Franklin County Commissioners, Franklin County Sheriff's Office, and the Department of Fleet Management and the same is hereby approved.
