

**Resolution authorizing a settlement to Bryan S. Fulgham for a disputed vehicle damage claim due to an auto accident involving a Franklin County Engineer's Office employee (Engineer) (\$500.00)**

**WHEREAS**, on February 21, 2015, a Franklin County Engineer's Office employee was involved in an auto accident; and

**WHEREAS**, during a snow and ice event, a vehicle owned by Bryan Fulgham was struck by a Franklin County Engineer's Office plow truck at the intersection of Stelzer Road and Agler Road; and

**WHEREAS**, Bryan Fulgham's vehicle sustained damage in the accident, injuries were not reported; and

**WHEREAS**, Franklin County Engineer's Office will pay for the property damage in the amount of five hundred dollars and zero cents, (\$500.00) for the damages done to Bryan Fulgham's vehicle in the accident that occurred on February 21, 2015 and Bryan Fulgham has accepted contingent on approval by the Commissioners; and

**WHEREAS**, the above described settlement fairly compensates Bryan Fulgham for the damages to his vehicle; and

**WHEREAS**, by agreeing to this settlement, neither Franklin County Engineer's Office employee Jared Keeling, the Franklin County Commissioners, nor the Franklin County Engineer's Office admits to any negligence or liability arising out of the auto accident; and

**WHEREAS**, the above described settlement, recommended by the Prosecuting Attorney's Office, is deemed to be in the best interest of the Franklin County Commissioners and the Franklin County Engineer's Office to settle the vehicle claim for five hundred dollars and zero cents, (\$500.00); now, therefore,

BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF FRANKLIN COUNTY, OHIO:

Section 1) That the above-referenced settlement in the amount of five hundred dollars and zero cents, (\$500.00) is in the best interest of the Franklin County Commissioners and Franklin County Engineer's Office, and the same is hereby approved.
