

**Resolution authorizing a contract extension to Hall Public Safety Columbus, LLC and ComProducts Inc., dba B&C Communications for Removal, Installation, Maintenance and Repair of all Vehicle Safety Equipment (Sheriff) (Est. Amount \$148,000.00)**

**WHEREAS,** The original contracts with ComProducts Inc., dba B&C Communications and Public Safety Concepts, LLC were approved on February 11, 2014 under Resolution No. 0105-14. The contract with Public Safety Concepts, LLC was Novated on March 25, 2014 under Resolution No. 0224-14 with the new company name being Hall Public Safety Columbus, LLC.; and

**WHEREAS,** the Franklin County Sheriff’s Office wishes to extend its contracts with Hall Public Safety Columbus, LLC and ComProducts Inc., dba B&C Communications for the continuation of providing Removal, Installation, Maintenance and Repair of all Vehicle Safety Equipment ; and

**WHEREAS,** the bid documents, specifications and prices submitted by Hall Public Safety Columbus, LLC and ComProducts Inc., dba B&C Communications shall remain in effect for the contract extension period, which is fully incorporated herein and binding on both parties; and

**WHEREAS,** the term of the contracts will be for a period of one (1) year, beginning April 26, 2016 through April 25, 2017 with each contract having one (1) additional one-year period; and

**WHEREAS,** the Franklin County Sheriff’s Office and the Franklin County Purchasing Department recommend the contract extension with Hall Public Safety Columbus, LLC and ComProducts Inc., dba B&C Communications for Removal, Installation, Maintenance and Repair of all Vehicle Safety Equipment be hereby approved; now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:
