

Resolution approving twenty-six (26) subaward agreements for the 2016 Franklin County Youth Summer Camp Program (Department of Job and Family Services) (\$3,288,898.01)

WHEREAS, the Franklin County Department of Job and Family Services is authorized to enter into a contract with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and
