

Resolution to approve the 2016 nomination of members for the Franklin County Dangerous Wild Animal Response Team (DWARD). (Franklin County Emergency Management & Homeland Security)

WHEREAS, pursuant to Ohio Revised Code (ORC) 935.27 the State of Ohio Dangerous Wild Animal Emergency Response Commission (DWAREC) determines the disciplines necessary for each county's Dangerous Wild Animal Response Team (DWARD); and,

WHEREAS, the State DWAERC has charged each county EMA with the organization of a county DWARD, and has requested that the County EMA's recommendations for membership be approved by the Board of County Commissioners; and,

WHEREAS, the ORC requires a DWARD be comprised of representatives from each of the following disciplines: law enforcement, first aid, health, elected local officials, fire-fighting, emergency management, broadcast and print media, and dangerous wild animal owners; and

WHEREAS, the State DWAERC further recommends that veterinarian and public health representatives also be appointed to each county DWARD;

WHEREAS, the membership to DWARD is not to exceed three years; now, therefore

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;
