

Resolution authorizing a Contract Extension with Scioto Services to provide Housekeeping Services at designated Franklin County Facilities.

WHEREAS, the Board of County Commissioners, Franklin County, Ohio ("County") wishes to secure the services of a qualified firm to provide Housekeeping Services at designated Franklin County facilities; and

WHEREAS, on April 9, 2013, sealed proposals for providing Housekeeping Services at designated Franklin County Facilities were received in response to Request For Proposals No. 2013-03-08; and

WHEREAS, Scioto Services, in its response and subsequent scope review sessions exhibited itself as qualified to provide the scope of services as outlined in Request for Proposals No. 2013-03-08; and

WHEREAS, Scioto Services, in its response and subsequent review sessions exhibited itself as qualified to provide the scope of services in a manner consistent with the County's Resolution No. 0247-10, adopted on August 29, 2006, emphasizing its commitment to promote sustainable principles in policy decisions and programs; and

WHEREAS, on August 6, 2013, as detailed in Resolution No. 0611-13, Scioto Services was awarded a Contract to provide Housekeeping Services at designated Franklin County facilities; and

WHEREAS, the Contract, contingent upon the satisfactory performance of Scioto Services, allowed for four 1-year extension periods; and

WHEREAS, on July 8, 2014, as detailed in Resolution No. 0477-14, Scioto Services was awarded a 1-year extension of the Contract to provide Housekeeping Services at designated Franklin County facilities; and

WHEREAS, on August 25, 2015, as detailed in Resolution No. 0635-15, Scioto Services was awarded a 1-year extension of the Contract to provide Housekeeping Services at designated Franklin County facilities; and

WHEREAS, both parties now wish to modify the Contract and exercise the third option for the period from August 6, 2016 through August 5, 2017; and

WHEREAS, the County has allocated funds in the 2016 Budget for securing Housekeeping Services; and

WHEREAS, the Franklin County Contract Form executed by the County and Scioto Services shall be the governing contract which is fully incorporated herein, and is binding on both parties; and

WHEREAS, Franklin County Public Facilities Management recommends the approval of the Contract Extension with Scioto Services to provide Housekeeping Services at designated Franklin County facilities; now therefore

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO;

1. That the attached Contract Extension by and between the Board of County Commissioners, Franklin County, Ohio and Scioto Services is hereby approved.
2. That the attached Purchase Order which is individually described in the accompanying Purchase Order Proof List in the amount of \$474,575.80 is approved.
