

Resolution authorizing a Contract Agreement with ms consultants, inc. to provide Professional Civil Engineering Services associated with the planning, design and construction of a new Correctional Facility as part of the Franklin County Public Safety Center.

WHEREAS, the Board of County Commissioners, Franklin County, Ohio ("County"), pursuant to the provisions of Sections 153.65 through 153.71, inclusive, of the Ohio Revised Code, wishes to secure the services of a qualified firm to provide Professional Civil Engineering Services associated with the planning, design and construction of a new Correctional Facility as part of the Franklin County Public Safety Center, to be located at 2551 Fisher Road, Columbus, Ohio; and

WHEREAS, ms consultants, inc. in its response and subsequent scope review sessions exhibited itself as qualified to provide the scope of services as outlined in the Request For Proposal No. 2016-03-08; and

WHEREAS, both parties wish to enter into a Standard Form of Agreement for Professional Design Services ("Agreement"); and

WHEREAS, the County has allocated funds in the 2016 Budget specifically for this project; and

WHEREAS, the term of the Agreement shall be for the period beginning August 16, 2016 through completion; and

WHEREAS, the Agreement executed by ms consultants, inc. and the County shall be the governing contract which is fully incorporated herein, and is binding on both parties; and

WHEREAS, Franklin County Public Facilities Management recommends the approval and execution of the Agreement; now, therefore

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

1. That the attached Standard Form of Agreement for Professional Civil Engineering Services with ms consultants, inc. in an amount not to exceed Four Hundred Ninety-Eight Thousand Four Hundred Seventy-Nine Dollars (\$498,479.00) is hereby approved.
